## TOWN OF RHINE -ANNUAL MEETING MINUTES

Tuesday, April 16, 2019

**1. Call to Order:** The Annual Meeting of the Town of Rhine was called to order by Chairman Ron Platz at 7:01 PM on Tuesday, April 16, 2019 at the Rhine Town Hall. Town Clerk/Treasurer, Lexann Hoogstra, recorded the minutes.

A motion to approve the 2017 Annual Financial Report was made by Al Feld. 2<sup>nd</sup> by Bill Jacob. No discussion. All in favor.

Platz mentioned that he has met recently with the accountant who stated that the finances are in good shape. Expenses were a bit higher due mostly to employee salary increases. There was a large capital outlay, which was for the fire ladder truck. The town had funds on hand for this expense.
